

Excellence Award Winners

AIRPORT EXECUTIVE OF THE YEAR



Brian O'Neill, A.A.E., who currently serves as Executive Director and CEO at Phoenix-Mesa Gateway Airport Authority (PMGAA), was awarded Airport Executive of the Year. He joined PMGAA in 2015 and prior to that worked at Manchester-Boston Regional Airport for twenty years. He serves on the Board for the Mesa Chamber of Commerce, Visit Mesa, East Valley Partnership, and Tempe Tourism Board. Under Mr. O'Neill's leadership Gateway Airport has

experienced unprecedented recovery from the pandemic, setting records for five of the last seven months. 2021 was Gateway Airport's second-best year on record with 15 new

destinations added. PMGAA also announced that Gulfstream Aerospace would be making the largest private investment in airport history by building a \$70, million 250,000 square-foot MRO facility. In addition, he led the announcement and recruitment of a master developer for Gateway East, a 400-acre non-aeronautical, mixed-use development that will begin in 2022. Brian is an active member of AzAA, testifying in the Arizona legislature in support of AzAA issues, and encourages staff membership. Finally, Brian supports an internship with ASU Polytechnic and the Mesa Leadership Program as well as a just-announced partnership with ASU on an airport student volunteer program.

CORPORATE MEMBER OF THE YEAR

Charlie McDermott, LEED AP, was named 2022 Corporate Member of the Year. Mr. McDermott is the Aviation Planning Manager at Dibble. In his 35 years working in the aviation consulting industry, Charlie has worked at over 100 airports, from general aviation to large hub commercial service, in 17 different states. Since moving to Arizona over 10 years ago he has been active with AzAA twice serving as Corporate Director. Charlie specializes in airport planning and environmental issues at airports, especially as it relates to FAA requirements and grant funding. Of note he created a vision for sustainable airport master planning and worked with his client at Ithaca Tompkins Regional Airport (New York) to develop a master plan fully incorporating sustainability into the planning process. This master plan project was nationally recognized. In Arizona he has led Master Plan projects at both Prescott Regional Airport and Buckeye Municipal Airport as well as serving as the President of the Scottsdale Airport Advisory Commission.

Alice Bimrose, A.A.E., ACE, received the President's Award and is Special Projects Administrator in the Facilities & Services Division at City of Phoenix Aviation Department. Ms. Bimrose has worked for the City for over 24 years in Public Relations, Capital Management, Design & Construction, Business Office, Directors Office, and HR. Stinknet:

A NOXIOUS WEED SPECIES AND SAFETY HAZARD

When most people think about the problem with noxious weeds, the first thing that comes to mind is the ecological impacts that they cause, such as outcompeting native species; however, a recent invader also presents human safety hazards. Stinknet (Oncosiphon piluliferum), also known as globe chamomile, is an annual plant with globe-like, yellow flowers and finely dissected leaves. Flowering usually occurs from November through April. It is native to South Africa and was first detected in California. In the past several years, it has invaded most of the Phoenix metro area, and it has started to invade the Tucson area. Currently, detections have been verified in most of the state. In 2020, the Arizona Department of Agriculture listed stinknet as a noxious weed species under Arizona Administrative Code R3-4-245.



The human safety concerns associated with this species include skin rashes and burns resulting from contact with the plant and, when the plant is flowering, eye irritation and breathing difficulties. It also burns readily and releases smoke that can cause eye irritation and breathing problems.

Treatment and control options include hand pulling the plant while wearing gloves, bagging it, and disposing of it at a landfill, or treating the plant with herbicides before it flowers. Current herbicide recommendations include:

- Pre-emergent Recommendations: Simazine 4L is recommended as a pre-emergent control of stinknet in residential areas. All label rates and restrictions must be followed and Simazine 4L must be applied by a commercial applicator.
- Pre-flowering Recommendations: Glyphosate with seed oil adjuvant is recommended as a post-emergent control of stinknet up to the flowering stage in wildlands, roadsides, and industrial and residential areas. Label rates and restrictions must be followed.

Updates from ADOT



Matthew Munden, Aeronautics Group Manager

- Aeronautics is expecting Board approval on its FY23 5-year ACIP by the end of June
- The FY23 SL program includes 20 grants at \$11.1M
- The FY 23 APMS program includes 28 grants at \$5.0M.
- The State Airports System Plan is set at \$1M in FY23
- We received the Aero Charts and will have them sent out to each airport by the end of June
- The heavy monsoon season has affected the construction timing of a few APMS '21 projects. The remaining APMS '21 construction projects will be completed in the spring and summer of 2022.
- The Triennial Study has been awarded is underway, with completion estimated at December 2022.
- We have funding to match FSL grants from the Bipartisan Infrastructure Law.

My mentor at Arizona State University was a grand old gentleman named Larry Gessell. Larry shared a story about how when he was the manager of an airport, no one in his community saw much value in the airport. No one believed that the airport was an economic engine. No one believed that the airport served anyone in the town other than the slim demographic of flyers. He wanted to prove them wrong. So one day Larry bought a bottle of Hai Karate, cheap cologne so bad that even I wouldn't wear it. Larry gave every bill in the cash register a little spritz and when new bills came in, he spritzed those, too. A month or so later, the town council had a meeting and numerous citizens complained about the money in town smelling like a disco. The stinky money was in the bookstore, all the restaurants and coffee shops, the grocery stores, you name it and every place of business in town had these Hai Karate dollars. Larry stood up and admitted that he was a culprit. Every malodorous dollar in that town was a dollar that came through the airport and was taken by a regular consumer into the greater marketplace. The townsfolk still weren't happy about the fragrant money, but the message was loud and clear: this airport is important to this community. Larry proved with this anecdote what we all know in our gut: Airports, despite being owned and operated by governments, are important businesses.

I just finished a book called *How to Navigate the Boom/Bust Cycle* by Murray Sabrin, a retired business professor at Ramapo College. Two things stood out. First, he had a graph that showed that every time the bond yield curve inverts (when the two-year bond pays more interest than the 10-year bond) a depression or recession follows within 12-18 months. The yield curve inverted in April 2022, so we may have the opportunity to seek alternative sources of revenue soon. The second thing that caught my attention was the word *intrapreneur*. An intrapreneur is a person or team inside of a staid organization that has the freedom and wherewithal to take risks and innovate. As soon as I saw that, I knew that airport managers fall into that category—or at least we should.

We intrapreneurs can take our knowledge that a recession is imminent and seek opportunities to create and innovate at our airports. Perhaps now is the time for you to have the airport take over the FBO. Instead of earning a small fuel flowage fee, you could earn an amount well over wholesale. The same goes for hangars. Now might be the time to convince your governing body that you must build hangars and t-shades. The waiting list is a mile long. That's an opportunity to profit by giving customers what they desperately want: covered aircraft parking. An airport can increase revenue much more by building and leasing hangars than you can by leasing raw land and having a private party build and lease hangars. Control your own fate regardless of what is happening at the macroeconomic level.

It can be hard to become an intrapreneur. You will face resistance from people who like the status quo. It can be also be hard to lose money year after year. Choose your hard. People in your organization may resist your efforts to find alternative streams of revenue. They may resent your creativity, drive, and innovation. However, there will also be people who deeply appreciate that in the face of challenges that are out of your control, you are moving forward with ideas and actions that will make your airport the economic engine that your sponsor needs it to be.
