The 2017 Arizona Aviation Day at the Capitol event, held on January 17th, could not have occurred on a more beautiful day – high clouds mixed with sun and temperatures in the 70's were perfect for promoting partnerships and fruitful discussion among aviation colleagues and members of Arizona's legislature.

For those that don't know, this event takes months of careful planning requiring coordination among a committee of AZAA members, volunteers, public safety officials, public works, contractors, vendors, FAA, ADOT, and, of course, our elected officials and their staffs. The success of these efforts and execution was evident in all facets of the 2017 Aviation Day event, and those that had a hand in organizing the event should be proud.

The event had a little different flavor this year as we had a number of speakers instead of the couple that we have historically had. This approach was well-received, and it gave the attendees some different perspectives on the positive impact of aviation in Arizona. The speakers' perspectives were bridged with a common theme – economic impact. Aviation has an economic impact of nearly \$60 billion in Arizona, and contributes a whopping 8% to Arizona's GDP. Consistent communication with our legislature is necessary by Airport sponsors, consultants, contractors, and other vendors because we are all affected by fund sweeps. ADOT Corner

Changes in the FAA Phoenix ADO



Since June of 2016 ADOT has engaged in a grant reimbursement request deferral plan. As explained in correspondence from August and October, there are a range of factors contributing to this lower-than-anticipated cash flow situation. As a result, the deferral plan remains in place.

ADOT believes that this condition will extend the deferral program further into calendar year 2017. Because of this deferral extension, ADOT is concerned that Exhibit C, Schedule Two of the grant document requesting the sponsor to submit a cash flow schedule does not portray a realistic payment schedule that the sponsor or ADOT can commit to in these times of extended/deferred reimbursement requests and payments. This section of the grant shows the sponsor's estimate of when cash reimbursements will be requested under normal State Aviation Fund conditions. Under the current conditions of extended grant reimbursement request payments, we believe a new approach to this section is necessary.

Over the next month, you will be contacted to discuss current and future funding requests you anticipate submitting. The intent of these discussions is to develop a clear picture of future expenditure requests and project timing. The goal of this effort is to provide you an estimated reimbursement schedule for decision-making and cash flow planning.

ADOT is considering a new Schedule Two that will allow for recognition of the sponsor's cash flow estimates and a formal notice from ADOT for an estimated date when payments are likely to start. ADOT would appreciate any input you can provide on improvements to this section of the grant agreement. This will take some time, but in the end all Federal/State/Local grants will be honored. Presently, ADOT has 14 pending Federal/State/Local grants that are temporarily held until these changes can be formalized. We are working on these changes and will present them to all of you during the Arizona Airports Association Conference in May; the staff of ADOT Aeronautics hopes to see you all then.

If you've not seen the latest update from Mike Williams, Manager of the FAA Phoenix ADO, the following recaps information related to staffing changes in the ADO:

Airport Spotlight



If you're considering flying into or out of Laughlin-Bullhead International Airport (IFP), rest assured that you will be flying with folks who are saying, "Great people!" or "Great little airport!" Don't let the word "little" fool you, though...IFP offers scheduled daily airline service by American Airlines from/to IFP and PHX, with over 70 one-stop destinations available with a connection in PHX. Two charter airlines also serve Laughlin-Bullhead - Sun Country Airlines and Elite Airways. At one point in early 2017, the airport had five airlines operating including Allegiant and Xtra Airways. In 2015, the airport served 213,310 total passengers. The addition of American Airlines in February of 2017 adds 51,100 total seats in and out of Laughlin/Bullhead International Airport, a large increase in passenger capacity. In addition to airline service, the airport regularly hosts military training detachments. In 2015 and 2016, the airport was home to the U.S. Navy Training Air Wing 4, with approximately 25 T-6B training aircraft operating from January through March. The U.S. Navy added over 20,000 aircraft operations during each year of detachment to the airport.

The initial construction of what is now Laughlin-Bullhead International Airport began in 1946 to serve as transportation for equipment and personnel building the Davis Dam Power Plant. The landing field was constructed on land then owned by the Bureau of Land Management. Through a series of leases and sub-leases (and associated improvement requirements) from 1968 to 1991 through various parties including the BLM, Mohave County, Bullhead Airport, Inc., and Mohave County Airport Authority (MCAA/Authority), the Airport finally came under its current location and operator (MCAA) under ownership of Mohave County.

Today, IFP is served by an 8,500-foot runway (16-34), a federal contract Aircraft Traffic Control Tower, an ARFF facility, two main terminals, a Fixed Base Operator (Signature Flight Support), and three rental car companies. In addition, the Airport now owns and manages a substantial Business Park in the "old" Airport location, which provides an excellent source of non-aeronautical revenue helping to keep the Airport self-sustaining. Airport Director, Jeremy Keating, and Assistant Director, Tim Bannon, lead a team of dedicated professionals to keep IFP running day and night, and to help maintain, if not help increase, the tremendous \$100,000,000 estimated annual economic impact to the region! Some notable improvements and accomplishments by IFP in recent years include constructing the Darryl E. Thompson Aircraft Rescue and Fire Fighting Facility in 2013 and constructing its largest project in two decades: a 1,000-foot extension to Runway 16-34 with associated taxiway and lighting improvements.

Whether you're looking for gaming fun at one of the nine casino resorts just across the Colorado River, looking for exciting water-sport activities in the River, or looking to explore the rugged terrain in northwestern Arizona, give IFP a try and see for yourself the convenience and pride of the Airport.
